### Blind Man's Bluff

#### *USS Seawolf (SSN 575)*

*Retold by Jack Munro*

At this time *Seawolf* went back to retrieve the cable tap pod, which weighed several tons, and was 18 to 20 feet long. The crew and a lot of higher-ups thought it was like sending a Model T to do the job. The year was 1986, and it was 28 years since the *USS Seawolf* had been commissioned. But *Seawolf* was one of the few boats that were equipped with skegs (retractable skis that held the boat off the bottom). The bottom had a lock out system allowing three divers on close-circuit umbilicals with hot water, to go out there, work, then go back to the chamber. Most of the work was in the 450 to 600 ft water range and they saturated down to do their work.

For this mission near the Sea of Okhotsk, they were at 450 feet, which is not really deep for a submarine to operate in. They purposely stayed away from the surface (because they were in a hostile area) and set up on the bottom. This was almost a fatal mistake, because two storms on the surface converged to form a cyclone right over their work site. With the divers delayed, the boat started to move, even with 400 plus feet over them. At first, slight rolls, then big enough that the skegs moved off the bottom. One of the divers lost his balance and fell under the skeg he was near and by sheer luck, was pulled out by his fellow divers right as the skeg came back down with a crash. This was enough for the divers; as they made their way back to *Seawolf*, the boat's movements and stirring up of the bottom was making life dangerous.

Inside *Seawolf* alarms were sounding all over. In engineering, water intakes were taking in sand and mud as much as water vital for cooling the reactor, turbine generators, pumpers, etc. At this point, loss or interruption of cooling water could cause a scram on the reactor and would result in complete loss of power. The boat was moving so badly that by now the skegs were burrowing themselves into the bottom making the situation even more dire. With two anchors out, they were trying to free the boat from the bottom, even blowing tanks and rocking the boat forwards and backwards (reverse).

The crew on *Seawolf* knew if they came to the surface by accident, as they were in Soviet waters, the consequences would not be good. After several meetings with the Captain, officers and chiefs, it was decided to let go of the anchors, then blow the tanks and take their chances with the Soviets which they figured would not be out in this type of weather. Many hours went by before they got the boat moving and got into deeper water, alarms still going off, machinery and reactors barely holding on. When they were finally loose, they realized the Gondola in *Seawolf's* belly, "huge clamshell" (used to retrieve pieces from the bottom) was damaged. But how bad was it?

The boat was so loud, with sand in every piece of machinery, that sooner or later they would be detected. Not too far from the Sea of Okhotsk, making only about 6 knots, they were detected. Active pinging from a Soviet vessel's sonar continued for 24 hours without let-up, then stopped. For whatever reason, the Soviets gave up, and *Seawolf* continued back to base. When in dry dock, they saw the damage was worse than depth charges. Lots of pieces of missing superstructure, the Gondola was dangling along with other pieces of metal, along with hundreds and hundreds of pounds of sand which became souvenirs to the crew. The shipyard workers were never told how the sand got into the diesel engine, lube oil system, pumps and vital machines. "No awards were given, no formal recognition of the men's brush with death." Officials in Washington had found out via satellite that the Soviets had found the cable tap in Okhotsk. At first, the crew was suspected of intel leaks, later it was proven that Ronald Pelton, former NSA employee, had sold out to the Soviets.

Not long after this last patrol, the *USS Seawolf* was decommissioned.

There were other earlier cable taps starting back to 1976 & 1977 made by the *USS Seawolf*, some highlighted in the excerpt below. Other spies, Aldrich Ames and John Walker Jr., who with other family members, sold secrets to the Soviets for 18 years, were all finally caught. Their hardware secrets not only helped the Soviets build better submarines, but also put our boats, crews, and divers in grave danger.

More stories will be coming out in the future about this and other adventures that will be stranger than fiction.

### Excerpt from "Subs, Spooks, & U.S. Navy Divers" United States Navy Divers

Much of the material relating to Submarine Development Group remains classified to this day, but with the publication of books such as Blind Man's Bluff and the Silent War several interesting facts about saturation diving have come into the public domains. Early submarine disasters and the related rescue efforts drove the Navy's need to dive deeper. As a result, NEDU (Navy Experimental Diving Unit) became the subject-matter experts on saturation diving and human performance at depth. By 1962, the Navy was involved in saturation diving with the Man-in-the-Sea project and in 1964 with Sealab I. The same year the Deep Submergence Systems Project (DSSP) was formed. But here is where it gets interesting, when, also in 1964, DSSP becomes an asset of Naval intelligence. Why was intelligence dabbling in submarine rescue?

In 1965 Sealab II had successfully saturated divers at 205 feet of sea water, demonstrating that they had moved passed the R & D stage and that saturation diving was now an operational capability for the Navy. The same year, naval intelligence came up with a highly classified plan, now known as "Sand Dollar" to recover Soviet missiles and parts from the sea floor. Defense Intelligence Agency (DIA) had approved DSSP to develop depth recovery capabilities for intelligence collection - and with that came funding.

With that approval, 1965 became a very busy year for deep diving. In July the submarine *USS Halibut* was reclassified and modified for DSSP operations. A new "phantom" bathyscaphe was built in absolute secrecy by DSSP, using the *Trieste* as a cover. And from 1965 to 1968, twenty-eight helium-oxygen saturation dives were made at NEDU to depths of 825 feet.

But why were they modifying submarines? The Navy could not very well place a salvage ship with a saturation diving system in Soviet waters without attracting undue attention. After all, this was the Cold War period.

From 1965 to 1967, *USS Seawolf* was refueled and upgraded to the new submarine quality assurance requirements, set in place after the *USS Thresher* (SSN 593) tragedy. She also became the flagship of Submarine Squadron Two. *USS Seawolf* was cut in half to be fitted with other equipment and to allow for the installation of a new section that would house divers who were trained for saturation diving.

In 1967 Submarine Development Squadron FIVE was established. At Naval Submarine Base, San Diego, California, and Bangor, Washington, included deep submergence rescue vehicles and diesel and nuclear-powered research submarines, as well as surface support ships. DSSP, under the supervision of Commander Jack Tomsky, developed the MK 2 MOD 0 Deep Diving System, and in 1968 the DDS was put aboard the *Elk River* (IX-501) to support Sealab III. The same year a record-breaking excursion dive to 1025 feet was made from a saturation depth of 825 feet at NEDU.

From 1969 until 1971, *USS Halibut* underwent modification at Mare Island Shipyard to support saturation divers. The chamber was hidden in plain sight, disguised as a DSRV attached to the rear deck of the submarine. In addition, in November, 1970, *USS Seawolf* transited the Panama Canal, changing her homeport from Groton, Connecticut to Mare Island Naval Shipyard in Vallejo, California, for conversion to a special projects platform.

In October, 1971, *USS Halibut* departed for the Sea of Okhotsk to tap into Soviet communications by placing

a magnetic induction unit over the cables running along the seabed, and then in August 1972, she departed on her second collection mission. Quoting from Blind Man's Bluff, a temporary cable running back to the sub allowed them to listen in on Soviet military conversations for a month. The intelligence information was "pure military gold".

In 1975, *USS Seawolf* came under the exclusive direction of Submarine Development Group ONE, and NEDU's principal focus became saturation diving systems and procedures. Between 1976 and 1977, *USS Seawolf's* divers, working at 400 feet, successfully tapped into Soviet communications cables in the Sea of Okhotsk, east of the Soviet Union. In 1978, *USS Parche* (SSN 683) ran the same mission profile under the code name "Ivy Bells". Between 1978 and 1980, *USS Parche's* divers also tapped into a cable in 500 feet of water of the Kola Peninsula, and on a later mission divers would work at 600 feet in the Barents Sea, north of Russia near Murmansk. Back at NEDU, divers completed a 37-day saturation dive to 1,800 feet of sea water in the Ocean Simulator Facility.

In the summer of 1980, *USS Parche* returned to the Okhotsk for divers to plant new taps and retrieve pods, and then to the Barents in the fall with the same mission. The collection pods, reportedly 20 feet long, 3 feet wide, and weighing 6 tons, were like large tape recorders that collected the communications passing through the undersea cables which had to be periodically retrieved by the divers for download.

From 1987 to 1991, *USS Parche* was in Mare Island Shipyard for an extensive refit and to have a hundred feet added to her hull, just forward of the control room and sail, to house "research and development" equipment. The R & D function included intelligence gathering and underwater salvage. Reportedly, the *Parche* was able to support overt intelligence-gathering operations by extending a remote grapple through a hatch in the keel to salvage relatively small items from the ocean floor such as missiles, nuclear warhead satellites, etc.

But during this same period, it was not just about the submarines. The submarine rescue ships *Pigeon* and *Ortolan*, with their Deep Diving Systems, were still actively involved in saturation diving. In the mid-eighties, the Elk River was being used to train saturation divers before they disappeared "up north" to the Dev Group Detachment and to become part of a Sea Comp Team.

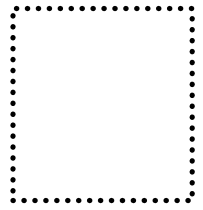
