VIDEOLIGHTS © 2001 Roger Roth Critter Feeding

[Editor's Note: Roger Roth writes Videolights, a monthly column on diving, for his club, the Northern California Underwater Photographic Society. He has graciously allowed us to reprint his past and present columns on a continuing basis. He would appreciate your comments]

In Florida on Nov. 1, a vote was taken to make a final decision on a bill, which outlaws fish and shark feeding by scuba divers and snorkelers. (It does not ban fish feeding and chumming by fishermen and anyone interested in killing fish.) There has been a concerted effort by divers to speak their minds on this, but to no avail as the bill passed, possibly due to some ignorance of the decision-makers.

The seven-member Florida Fish and Wildlife Conservation Commission stated that this bill, that takes affect Jan. 1, 2002, is solely aimed at assuring that the sharks do not become more dangerous. Opponents of "interactive diving" say the practice alters the animals' natural behavior and teaches the animals to associate people with food.

It is quite obvious that this bill has gained some momentum since the numerous shark attacks this past summer around Florida, although this has been denied by the commission. Some of these decision-makers have determined, in all their wisdom, that divers feeding fish and sharks contribute to the cause of these attacks. Not that more and more tourists are crowding the shark's habitats, including their migration routes, and over-fishing the shark's hunting territories. And no consideration seems to have been given to the fact that in the 30-year history of marine life feeding, there has not been a single attack on a swimmer within one

hundred miles of a feeding site.

This brings to mind the topic of critter feeding in general, and is one debated continually between extreme conservationists and realists. These conservationists feel that feeding fish, especially compressed cheese from cans, is not a way to conserve the natural balance and diet of these fish. They also state that it causes these fish to depend on divers feeding them and will lose their ability to hunt for their own food. (Will this really tame a shark? What a novel idea to solve man's everlasting "hatred" for sharks!)

The realists agree with the fact that the marine life needs to be fed food that's in their natural diets, and many do their utmost to teach this to others. Whether a conditioned response by this marine life of forgetting how to hunt and feed will ensue, has yet to be studied to any extent, but scientists don't think this will likely happen in general.

I, personally, see and understand many conservation reasons why some feeding is unnatural, but also see numerous benefits to allowing divers to do this in a conscien-

tious way. The knowledge gained from such experiences of divers has surely been passed on to other divers, non-divers, school children, and even senior citizens. All of this creates a new sense of awareness of the beauty of the natural order in the marine environment.

It also serves to instill a curiosity that motivates us to understand this environment on a real level. The numbers of marine behaviorists are growing. Our knowledge is growing. Our interest is growing. All of this will positively contribute to our efforts to conserve this most precious resource.

Each marine life feeding that I've participated in has taught me something new, and learning it first-hand has helped to imprint this knowledge. The first time I fed an eel, I had my fingers extended with the squid just past them. As the eel came out and quickly grabbed the squid, the tooth on its upper palate sliced through the knuckle and fingernail of one of my fingers. I learned to hold the squid in my fist and to let go quicker!

While feeding stingrays at Stingray City, I realized their tameness and the fact that their tail barbs are for defense. Feeding fresh fish to an anemone showed me how the anemone tentacles pass the food from one to another until it's passed to the mouth and disappears. Even a sand tilefish in Cozumel that I randomly fed fresh fish to, seemed to enjoy the encounter as much as

I, but I'm sure I didn't cause it to forget how to hunt.

During my first shark feeding encounter, I noticed that the sharks were more interested in the bait rather than divers as a source of food, and that they immediately left the area once the bait was gone. During subsequent shark feeds and dives, I began to recognize a hierarchy in the feeding, as some species of sharks will wait until other species have been fed and then back off.

After 20-30 hours of these types of dives in the same locations, I've begun to recognize individual sharks from years past by their scars. Yes, these sharks are recognizable, do seem to gravitate to these feeding grounds, and tend to remain in the group for years! And new sharks to the group learn the protocol from the "old hands." All of this lends credibility to a higher intelligence level of sharks that we probably were not aware of previously.

Is the value of this new found knowledge worth the infringement of an "unnatural" feeding? To me, it is. Being able to bring pictures and video proof that will enlighten others about the marine environment seems to be well worth crossing the conservation line, as long as it's done in a way that will not alter nor harm the marine life involved.

Do I think these shark feedings have caused the recent shark attacks in Florida to increase? No, I do not. Do I think that conscientious fish feeding will greatly alter the marine ecosystem? No, again. Prudent and thoughtful marine encounters can serve to not only enhance our dive experiences, but will also draw us closer to a better understanding of how to preserve a sustainability in our oceans. Let's all hope this precedent set by Florida law-makers does not extend itself to other corners of the world! Sea Ya!

Critter corner: Dr. Samuel Gruber, of the University of Miami, has studied sharks for decades and has noticed that when Caribbean Reef sharks do attack divers, the sharks seem to most always attack towards the face of divers. He has determined that this is probably due to the likeness of a regulator to a fish hanging out of one's mouth. If you've ever participated in a shark feeding, you may have noticed some sharks going after a piece of bait hanging out of another shark's mouth!

equipment would remain unchanged.

The dive itself was also perfect. The entry long the sloping rock ledge make for easy access. Sufficiently weighted, I slipped below the surface without having to grab the nearest large rock. The rocky bottom provided an wondrous landscape(?), seascape(?), oceanscape(?), world to explore. There were sea ravens hiding in the sea weed and crabs scurrying everywhere. Visibility was good (15 to 20 feet). The water was cool but comfortable, if I kept moving. We followed the rocky bottom downward to a depth of about 40 feet. A personal record depth. It was great to focus on the world below the waves and not be preoccupied with my equipment or my breathing.

After about 40 minutes we surfaced. The sloping ledge provided as easy an exit, as it had an entrance. Shore support helped gather-up fins and dive accessories. I lumbered under the weight of my gear to the car parked up the hill.

The day itself was delightful. The weather was sunny and warm. Friends were nearby to share the wonders of the dive and to enjoy the afternoon.

Notes from the Bay State Council Meeting, November 13, 2001

The Bay State Council met on November 13 in Quincy. Five North Shore Frogmen attended.

An article in the October issue of Diver's Digest published by the New York State Divers Association, reported that Jeff Nadler, PADI's representative to the UNESCO Convention, supports UNESCO's recommendation to make (certain) wrecks off-limits to divers. According to the article, Mr. Nadler believes that wreck divers are looters. It is suggested by members of the Bay State Council that this is an unfortunate position for PADI to take. A copy of a letter written by the secretary of the South Shore Neptunes was handed out to be used by those wishing to write a letter to PADI. Bruce states in his letter "We feel strongly that it is very unfortunate that PADI should be siding with a minority of individuals who are suspicious of divers."

There was a report on the artificial reef site work that the Bay State Council has been doing. Members of the Bay State Council and other dive clubs did do two transect dives this year with the help of the MA Division of Marine Fisheries, on June 10 and September 23. The two sites, both near Nahant, were found, on first inspection, to be silty and without a great deal of marine life. They might turn out to be clam beds, in which case they might be less desirable sites for artificial reefs that first impressions would suggest. The divers logged their finds along transect lines, and videos were taken on several dives. The GPS positions of the transect lines were logged.

There were suggestions made for some things to be done over the winter.

Have a transect-line making party for all the dive clubs so that each club could have their own sets of lines, making divers less dependent on the Dept. of Marine Fisheries when a dive is undertaken. This party – date to be determined – would be held somewhere with long hallways or a nearby park or parking lot to assist in the measuring and tagging of the 100 meter lines which are used for the transect dives. Pizza and beer will be the menu.

Think about what you would want to put down for the reef (i.e. – cobble, rock, preformed cement structures (reef balls), boats/ships).

Gather requirements for doing the survey dives. (Boats, divers, how to.)

It was pointed out that there are three parties working on this artificial reef project, the divers and the Bay State Council who are doing the surveys of the sites, the MA Dept. of Marine Fisheries who will do the required permitting for the sites, and NEARS which is working on fund raising and publicity for the project.

Vince Malkoski of the Dept. of Marine Fisheries reminded us of some ongoing issues:

Duke Energy is working on a project to build a 35-mile natural gas pipeline across the bay from the north shore to Weymouth, crossing Deer Island along the way.

Under pressure, they are starting to do marine studies now. They are mapping the bay along the areas they plan to run the pipeline. "We" are looking for a higher resolution to the mapping, and maybe we will receive some benefit for the artificial reef project.

A private concern has plans to build 195 windmills on Horseshoe Shoals in Nantucket Sound. This seems like a great idea, as it proposes to provide 75% of the electricity for Cape Cod. But there are concerns from environmentalists. The windmills would be 21feet across the base, and 300 feet tall, with 100 foot rotor blades.

The shoal waters are about 5 feet deep, and are a tremendous resource area for marine life. A sandy area nearby is a known quahog grounds. It is also a flyway for migrating birds.

The MDC has plans for a major sand mining project to shore up the beaches of the town of Winthrop. Their plans are to harvest 1 million yards of sand to replace that lost as the result of poorly conceived jetties.

NEARS (The New England Artificial Reef Society) will hold their next general membership meeting (open to all!, not just members) on December 12th in Natick, at the office of Tony Blanchette. Contact Dale Findlay for more information. Dues are \$20 per year. Their web site is www.nears.org.


